The Board of Eaton County Road Commissioners has advertised for bids to be received at 1112 Reynolds Road, Charlotte, Michigan 48813, until 9:30 A.M. Tuesday, November 8, 2016, for furnishing and delivering SAND FOR ICE CONTROL in accordance with the following specifications.

Bid prices shall include the cost of delivery to the locations indicated on the bid blank and shall remain firm until June 1, 2017.

This material shall meet the requirements for MDOT Fine Aggregate Number 2NS as designated in Table 8.02-4, Page 497 of The 1990 Standard Specifications for Construction.

Sand for Ice Control shall be measured by volume in cubic yards - loose measure in the hauling unit.

Bids must be submitted on bidding blanks furnished by the Eaton County Road Commission and all proposals must be in sealed envelopes bearing the name of the bidder with a notation indication "SAND BID".

The Board of Eaton County Road Commissioners reserves the right to reject any or all bids, waive defects and accept the bid which, in their opinion, is the most advantageous to the County of Eaton.

This contract is for the period of November 2016 through June 1, 2017 and the contractor's bid unit price shall remain firm for the duration of the contract.
