GRADER BLADES

The Board of Eaton County Road Commissioners has advertised for bids to be received at 1112 Reynolds Road, Charlotte, Michigan 48813, until 4:00 p.m., Tuesday June 16, 2020, for furnishing and delivering GRADER BLADES meeting the following specifications.

Bid prices shall include the cost of delivery to 1112 Reynolds Road, Charlotte, Michigan and shall remain firm until August 1, 2020.

Thru Hardened Steel Blade

Blade material to be 15B30 modified steel (Nominal ASTM grain size 5 minimum). Thru-hardened to BN 400-464, RC 43-50. All hardness to be compatible with harden ability band for 15B30 steels.

All Blades

Shall be furnished with 11/16" square holes punched in accordance with U.S. standard spacing and shall be countersunk. Hole spacing dimensional tolerances shall be $\pm 1/16$ " non-accumulative. The finished blades shall be free from warp or other defects and the ends shall be square and cleanly cut.

All blades shall be stamped with the company's name and date.

Bids must be submitted on bidding blanks furnished by the Eaton County Road Commission and all proposals must be in sealed envelopes bearing the name of the bidder with a notation indicating, "GRADER BLADE BID".

All deliveries to be made as requested F.O.B. to the Eaton County Road Commission, Charlotte Garage.

All blade deliveries must be made on flat bed trailers with sides removed to facilitate unloading by the Road Commission's forces.

The Board of Eaton County Road Commissioners reserves the right to reject any or all bids, waive defects and accept the bid which, in their opinion, is the most advantageous to the County of Eaton.

If requested, the bidder shall furnish a sample of the blade for inspection.
