The Board reviewed and discussed the bid tabulations for the 2020 pavement marking as presented by Assistant County Engineer, Mr. Hannahs. Motion by Lamoreaux and seconded by Frazier to award the 2020 pavement marking contract to Michigan Pavement Markings, LLC, being the low bidder. Motion carried.

The Board reviewed and discussed the bid tabulation for 2020 HMA Base Crushing as presented by Assistant County Engineer, Mr. Hannahs. Motion by Lamoreaux and seconded by Frazier to reject the bid as presented for 2020 HMA Base Crushing. Motion carried.

The Board reviewed and discussed the Overband Crack Fill-Contract A with Wolverine Sealcoating, LLC as presented, with a recommendation that the Board approve the contract. Motion by Lamoreaux and seconded by Frazier to award the Overband Crack Fill-Contract A, to Wolverine Sealcoating, LLC., being the low bidder. Motion carried.

Assistant County Engineer, Mr. Hannahs updated the Board on the status of 2020 road projects.

The Engineer/Manager, Mr. Ballou updated the Board on maintenance activities. A 2020 project map is available on the road commission website.
