

SPECIAL PROVISION FOR MAINTAINING TRAFFIC

ECRC 1 of 1 04/21/22

- **a. Description.** This special provision consists of requirements and restrictions to maintain traffic on all crush and shape jobs in Eaton County.
- **b. General.** Traffic control shall be provided for the duration of the project as indicated on the project maps in accordance with Sections 104.11 and 812 of the 2020 Michigan Department of Transportation Standard Specifications for Construction, the Special Provisions, and as specified herein. Signs must meet MMUTCD specifications.
- **c. Traffic General.** Project location maps with specified signs and locations are provided within this bid package. All signs, warning lights, barricades and all other traffic control devices, methods, and procedures shall be in accordance with the 2020 Michigan Department of Transportation Standard Specifications for Construction, the 2011 revision of the Michigan Manual of Uniform Traffic Control Devices (MMUTCD), and as specified herein. The contractor is responsible for staking sign locations before signs are post driven.

All temporary sign supports for detour and traffic control **shall be driven** per MDOT Standard Plan WZD-100-A and the 2020 Standard Specifications for Construction before any construction is permitted to start.

- **d. Schedule.** Work is expected to begin in mid-May and be completed by the end of August. Projects completed prior to the end of August shall have the signs removed when directed by the Engineer. Signs shall remain for projects that are not complete and open to traffic by the end of August. The Contractor should expect all projects to be closed concurrently
- **e. Measurement and Payment.** Items used for this project will be measured and paid for in accordance with the 2020 Michigan Department of Transportation Standard Specifications for Construction, except the **Oper** and **Furn** items will not be measured separately. Payment for the item will include all work, materials, equipment, and labor included in both the **Furnished** and **Operated** items as specified in the standard specifications.

Traffic control devices will be measured separately at each project location. Unit price payment for all traffic control items delivered and installed on these projects will be payment in full. Minor Traffic Devices is not a pay item on this project.

No payment will be made for devices damaged during construction.
