A regular meeting of the Eaton County Board of Road Commissioners was held in the Board Room at the Road Commission offices in Charlotte, Michigan on November 14, 2023, at 8:30 a.m.

The Board reviewed and discussed the bid tabulation for Grader Blades as presented and recommended by the Superintendent. Motion by Lyons and seconded by Barber to award the grader blades type 1 to Heights and grader blades type 3 to St Regis, being the low bidders in those types. Motion carried.
