## April 9, 2024

A regular meeting of the Eaton County Board of Road Commissioners was held in the Board Room at the Road Commission offices in Charlotte, Michigan on April 9, 2024, at 8:30 a.m.

The meeting was called to order by Chair Eldred at 8:30 am

The Chair inquired if there were additions or deletions to the agenda. There were no additions or deletions to the agenda. Motion by Barber and seconded by Lyons to approve the agenda as presented. Motion carried.

The Chair asked if the minutes of the March 26, 2024, meeting were correct as presented. Motion by Lyons and seconded by Lamoreaux to approve the March 26, 2024, meeting minutes as presented.: Motion carried.

Ryan Slamka of Maner Costerisan gave a short presentation of the FY 2023 Financial Audit to the Board. Motion by Lyons and seconded by Lamoreaux to accept and place on file the FY 2023 Financial Audit. Roll call vote: Ayes: Eldred, Barber, Lamoreaux, and Lyons. Nays: None. Absent: Aitch-Guerrant. Motion carried.

The Finance Director presented the 2023 MDOT ACT 51 Annual Financial Report to the Board. Motion by Lyons and seconded by Lamoreaux to accept and place on file the

2023 MDOT Act 51 Annual Financial Report, authorizing the Chairman and Chief Financial Officer to attest and sign the report. Roll call vote: Ayes: Eldred, Barber, Lamoreaux, and Lyons. Nays: None. Absent: Aitch-Guerrant. Motion carried.

The Board reviewed and discussed the bid tabulation for reconstruction and crush & shape of Royston Road. Motion by Lyons and seconded by Lamoreaux to award the reconstruction and crush & shape of Royston Road to Nashville Construction Co., being the low bidder. Motion carried.

The Board reviewed and discussed the contract with Nashville Construction Co for the reconstruction and crush & shape of Royston Road. Motion by Lyons and seconded by Barber to approve the contract with Nashville Construction Co. as presented. Motion carried.

The Board reviewed and discussed the pavement marking bid tabulation as presented by the Engineer-Manager. There was only one bidder as our previous notification process was not followed, so past bidders were not alerted to the bid notice. The Engineer-Manager recommended the Board reject the bids and the work will be re-bid. Motion by Lamoreaux and seconded by Lyons to reject the bid for pavement marking. Motion carried.

The Board reviewed and discussed MDOT agreement 24-5135, Smithville Road Bridge.

Commissioner Timothy J. Lamoreaux motioned for the adoption of the following resolution:

WHEREAS the Michigan Department of Transportation wishes to enter into a contract agreement with the Eaton County Road Commission to accomplish the following project:

Hot mix asphalt surface removal and resurfacing with waterproofing membrane of the structure #2403, which carries Smithville Road over the Grand River, Section 2, T01N, R03W, Hamlin Township, Eaton County, Michigan; including expansion joint replacement, concrete railing repair, concrete substructure and fascia box beam repair, scour protection repairs, hot mix asphalt approach work, guardrail and permanent pavement markings; and all together with necessary related work, in Eaton County, Contract No. 24-5135, Job No. 215121CON, Control Section BO 23000.

NOW, THEREFORE, BE IT RESOLVED, that Mathew M. Hannahs, PE, Engineer/Manager shall be duly authorized to sign the contract for the Eaton County Road Commission.

BE IT FURTHER RESOLVED that true copies of this resolution will be sent to the Michigan Department of Transportation.

The Board reviewed and discussed the bid tabulation for the 2024 lawn care as presented by the Superintendent. Motion by Lyons and seconded by Lamoreaux to award the 2024 lawn care to Gaedert Lawn Care, Landscaping, and Snow Plow. Motion carried.
