## EATON COUNTY ROAD COMMISSION

## March 26, 2024

A regular meeting of the Eaton County Board of Road Commissioners was held in the Board Room at the Road Commission offices in Charlotte, Michigan on March 26, 2024, at 6:00 p.m.

Members present: Commissioners Eldred, Lamoreaux, Barber and Lyons

Members absent: Aitch-Guerrant

The meeting was called to order by Chair Eldred at 6:00 p.m.

The Chair inquired if there were additions or deletions to the agenda. The Engineer-Manager asked that Consider Plat Waiver be added. Motion by Lyons and seconded by Barber to approve the agenda with the addition. Motion carried.

The Chair asked if the minutes of the March 12, 2024, meeting were correct as presented. Motion by Lyons and seconded by Barber to approve the March 12, 2024, meeting minutes as presented.: Motion carried.

Public comment: Jake Lesmeister, resident of Winding Way asked questions and voiced concerns regarding the 2024 road work to be done on Winding Way, within the subdivision.

The Board reviewed and discussed the bid tabulation for the 2024 HMA Resurfacing Contract A as presented by the Engineer-Manager. Motion by Lyons and seconded by Barber to award the 2024 HMA Resurfacing Contract A to Lakeland Asphalt being the low bidder. Motion carried.

The Board reviewed and discussed the roof replacement contract with Weather Shield as presented by the Engineer-Manager. Motion by Lamoreaux and seconded by Lyons to approve the roof replacement contract with Weather Shield. Motion carried.

The Board reviewed and discussed the 2027 Local Bridge Applications as presented by the Engineer-Manager. Motion by Benjamin S. Lyons to adopt the following resolution:

WHEREAS, this Board of Eaton County Road Commissioners has been advised that there are bridges in Eaton County in need of repairs that are eligible for Federal and State Funds through the Local Bridge Program, and

WHEREAS, three of those bridges are as follows:

1	Vermontville Hwy (2345)	Little Thornapple River	Replacement	Chester
2	Marshall Rd (2364)	Big Creek	Rehabilitation.	Walton
3	Stine Rd (2432)	Battle Creek River	Replacement	Walton

WHEREAS, closure of these bridges would cause significant problems and delays to the traveling public, agriculture, and other commercial traffic in these parts of Eaton County, and

WHEREAS, there are local bridge funds available through the Michigan Department of Transportation to perform preventative maintenance, rehabilitation, and replacement on structures such as these, and

WHEREAS; this Board has considered the applications for Local Bridge Program Funds and authorizes the submission of the applications for Local Bridge Program Funds for Fiscal Year 2027 for those bridges listed in this resolution.

NOW, THEREFORE, BE IT RESOLVED that the Board of County Road Commissioners of the County of Eaton does request affirmative consideration of our application for Local Bridge Program Funds and agrees to provide the necessary local funds for these projects if awarded.
